NOTES

The applicant must give public notice in such form as the Council may prescribe of the application by publishing an advertisement in a local newspaper circulating in the authority's area not later than 7 days after the date of the application of his intention to open such an establishment, and within the same period the applicant must send a copy of the application to the Chief Officer of Police.

Where the application is in respect of premises, notice of it shall in addition be displayed for 21 days beginning with the date of the application on or near the premises and in a place where the notice can conveniently be read by the public.

Every notice which relates to premises shall identify the premises.

Every such notice which relates to a vehicle, vessel or stall, shall specify where it is to be used as a sex establishment.

Planning permission may be required for the use of premises as a sex establishment and it is in the applicant's interest to clarify the position with the Head of Planning, Civic Offices, Civic Way, Swadlincote, Derbyshire. DE11 OAH
