

Local government elections in England

The days which are disregarded in calculating the timetable are Saturday, Sunday, Christmas Eve, Christmas Day, Good Friday or a bank holiday or any day appointed for public thanksgiving or mourning.

A monthly notice of alteration will be published on the first working day of every month, except in the month when the revised register is published and in the two months before that day. Ask the Electoral Registration Officer for details of these dates.
